COMPULSORY ACQUISITION OF LAND

Hill Street Area, Compulsory Purchase (Development and Amenity) Order 2025.

NOTICE OF A COMPULSORY PURCHASE ORDER UNDER SECTION 76 OF AND THE THIRD SCHEDULE TO THE HOUSING ACT, 1966, AS EXTENDED BY SECTION 10 OF THE LOCAL GOVERNMENT (NO.2) ACT, 1960 (AS SUBSTITUTED BY SECTION 86 OF THE HOUSING ACT, 1966) TO BE PUBLISHED IN ACCORDANCE WITH ARTICLE 4 (a) OF THE THIRD SCHEDULE TO THE HOUSING ACT, 1966, AS AMENDED BY THE PLANNING AND DEVELOPMENT ACTS 2000 to 2024.

Dublin City Council (hereinafter referred to as "the local authority") in exercise of the powers conferred upon it by section 76 of the Housing Act, 1966, and the Third Schedule thereto, as extended by section 10 of the Local Government (No. 2) Act, 1960 as substituted by section 86 of the Housing Act, 1966 as amended by section 6 of and the Second Schedule to the Roads Act, 1993 and as amended by the Planning and Development Acts 2000 to 2024, has made an order entitled as above which is about to be submitted to An Coimisiún Pleanála for confirmation. If confirmed, the order will authorise the local authority to acquire compulsorily the land described in the Schedule hereto for development and amenity purposes.

Owners, lessees and occupiers of the land described in the Schedule will receive individual written notice.

If an objection is made in respect of the acquisition by an owner, lessee or occupier of the land and not withdrawn the Coimisiún may, at its absolute discretion, hold an oral hearing into the matter and consider the objection and the report of the person who held the oral hearing.
