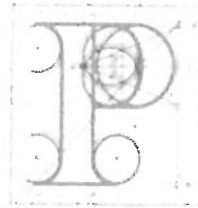

Dear Sir/Madam

We have examined the route identified for the Limerick City Greenway (U.L to N.T.P) Project within the townlands of Dromore, Sreelane, Newcastle and Castletroy, County Limerick. and we have no observations concerning the proposed route. The Consultants might be advised concerning the requirements under section 50 of the 1945 Arterial Drainage Act.

Under Section 50 of the Arterial Drainage Act, 1945, the consent of the Commissioners of Public Works is required for the construction of any bridge or culvert in or over a watercourse. To obtain consent, the design engineers are required to submit evidence to this office showing that the proposed structure will not increase the risk of flooding. The documentation required would normally include, inter alia:

- Design drawings and long sections, referenced to Ordnance Datum for the proposed structure(s),
- Design standard of the structure(s) with reasoning,
- Hydrological calculations to determine the design flow(s),
- Hydraulic calculations to demonstrate that the structure(s) will not increase water levels (for discharges up to the design flow) above those experienced prior to construction.

Consent under section 50 will be required for all culverts and bridges over all watercourses that form part of this project.
