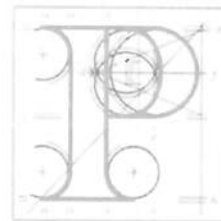

Dear Sir / Madam,

I have been asked by An Coimisiún Pleanála to refer to the above case.

In accordance with Section 221(2)(a) of the Planning and Development Act 2000, as amended, it is a statutory objective of the Commission to ensure that every application for consent under the Derelict Sites Act, 1990, received is determined within a period of 18 weeks, beginning on the last date for making objections, observations or submissions.

Where it appears to the Commission that it would not be possible or appropriate to determine a particular case within this period, a notice must be sent to the local authority and objectors in accordance with Section 221(3)(a) of the 2000 Act, as amended.

The Commission hereby serves Notice under Section 221(3)(a) that it appears to the Commission that it would not be possible/appropriate to determine the above case within the period of 18 weeks (i.e. by 26th January 2026) due to a high volume of caseload on hand. The Commission regrets the delay in determining this case.

The Commission intends to determine the above case before 2nd February 2026. The Commission will take all such steps as are open to it to ensure that the matter is determined before that date.
