

Avoid Asian hornets, experts advise after nest is found in Cork

An Asian hornet nest has been found near Cork city following sightings of the insects, which pose a threat to honeybee populations.

It was identified "in and around" where Asian hornets were seen in the "southern side of Cork city" last month, junior minister Christopher O'Sullivan said.

The nest will be removed and the hornets destroyed, with further tests due to be carried out on the nest to locate where they may have come from.

Speaking to RTE's *Morning Ireland*, Mr O'Sullivan said he could not give an exact location, but it was confirmed yesterday that the nest was found by the National Parks and Wildlife Service after an exhaustive search.

"We suspected over the last couple of weeks that this might be the case," he said.

"I know people may be alarmed by the fact that we now have a confirmed sighting of an Asian hornet nest because of the devastating impacts that an Asian hornet outbreak would have on biodiversity and nature in general – but it is a success story.

"You have to understand the timeline of this species. It is expected that every nest will contain a number of queen hornets.

"Obviously, if queen hornets get out into wider circulation, they may go on and build their own nests and the population may increase that way."

Mr O'Sullivan said there was pressure to locate the nest as queen hornets leave their colonies later in the autumn.

"We believe we have got ahead of this by the quick effort of National Parks and Wildlife rangers," he added.

The nest will be taken to the National Museum of Ireland where entomologists will carry out further investigations "to find out exactly where we think that this original hornet may have originated from".

A spokesperson for the Department of Housing said the survey and monitoring team have "intensified efforts" after the recent sightings.

The Asian hornet management group has been established, has consulted with experts from the UK and is monitoring the situation.

"The location of sightings and monitoring activities are not being disclosed for operational purposes," the spokesperson said.

"The Asian hornet is not generally aggressive, but it may sting if provoked.

"The public are therefore advised not to approach or attempt to capture a suspected individual, but instead to report any suspected sightings through the National Biodiversity Data Centre's reporting portal, including a photograph if possible."

Galway County Council hereinafter referred to as "the local authority") in exercise of the powers conferred
upon them by section 76 of the Housing Act, 1966, and the Third Schedule thereto, as extended by section
10 of the Local Government (No. 2) Act, 1960 as substituted by section 86 of the Housing Act, 1966 as
amended by section 6 and the Second Schedule to the Roads Act, 1993 and as amended by the Planning
and Development Act, 2000, has made an order entitled as above which is about to be submitted to
An Coimisiún Pleanála for confirmation.

If confirmed, the order will authorise the local authority to acquire compulsorily the land described in the
First Schedule hereto for the purposes of the Housing Act, 1966, to construct the N63 Abbeyknockmoy
Village Active Travel and all ancillary and consequential works including the provision of structures, road
pavement, road markings, access and accommodation works, and other ancillary works, in the townlands of
Culligh South (ED: Abbey West), and Culligh North (ED: Abbey West).

Owners, lessees and occupiers of the land described in the Schedule will receive individual written notice.

The Housing Act, 1966, as amended, provides that the Commission cannot confirm the order in respect of
the land if an objection is made in respect of the acquisition by an owner, lessee or occupier of the land, and
not withdrawn, until it has held an oral hearing into the objection and until it has considered the objection
and the report of the person who held the oral hearing but, not withstanding the above, An Coimisiún
Pleanála has an absolute discretion under Section 218 of the Planning and Development Act 2000 as
amended by Section 39 of the Planning and Development (Strategic Infrastructure) Act 2006 to hold an
oral hearing.
