Galway County Council hereinafter referred to as 'the local authority' / in exercise of the powers conferred upon them by section 76 of the Housing Act, 1966, and the Third Schedule thereto, as extended by section 10 of the Local Government (No. 2) Act, 1960 as substituted by section 86 of the Housing Act, 1966 as amended by section 6 and the Second Schedule to the Roads Act, 1993 and as amended by the Planning and Development Act, 2000, has made an order entitled as above which is about to be submitted to an Commission Pleanail for confirmation.

The Housing Act, 1966, as amended, provides that the Commission cannot confirm the order in respect of the land if an objection is made in respect of the acquisition by an owner, lessee or occupier of the land, and that the person who held the oral hearing but, notwithstanding the above, an Commissioner has an absolute discretion under Section 218 of the Planning and Development Act 2000 as amended by Section 39 of the Planning and Development (Strategic Infrastructure) Act 2006 to hold an oral hearing.
