

Dear Sir / Madam,

An Coimisiún Pleanála has received a direct planning application for approval by Ballinla Wind Farm Limited with regard to the above-mentioned proposed development under section 37E of the Planning and Development Act 2000, as amended.

In accordance with Article 213 of the Planning and Development Regulations 2000, as amended, you are requested to make observations in relation to the proposed development. An observation to the Commission should relate to:

- (i) the implications of the proposed development for proper planning and sustainable development and
- (ii) the likely effects on the environment of the proposed development, if carried out.

Please note that An Coimisiún Pleanála following its consideration of the application can decide to:

- (i) grant the permission/approval, or
  - (ii) make such modifications to the proposed development as it specifies in its decision and grant permission/ approval with regard to the proposed development as so modified, or
  - (iii) grant permission/approval with regard to part of the proposed development (with or without specified modifications of it of the foregoing kind), and any of the above decisions may be subject to or without conditions, or
- (b) refuse to grant the permission/approval.

Any observations to the Commission should be made within 14 days of the date of this letter. Your response should be made to the Commission on or before the **22nd December 2025**.
