To: OWNER/OCCUPIER

Cork County Council (hereinafter called "the Local Authority"), being of the opinion that the land referred to hereunder is a derelict site within the meaning of the Derelict Sites Act, 1990, hereby gives notice of its intention to enter particulars of the said land on the Derelict Sites Register in accordance with the provisions of Section 8(1) of the Derelict Sites Act, 1990.
