Ref -Formal Objection to Planning Application 323635 – Proposed Wind Farm on behalf of Garrane Green Energy Ltd at the Townlands of Garrane,Ballynagoul, Cregane ,Co Limerick.

Dear Sir/Madam ,

I am writing a letter of concern on behalf of my children in relation to the proposed erecting of 9 wind turbines and associated ground works on behalf of Garrane Green Energy limited.

My house is just outside the 1km zone from a wind turbine.

I have 2 [REDACTED] boys and 1 child [REDACTED]. I am seriously concerned regarding the visual impact, noise and shadow flicker.

Any one of the above 3 would cause serious side effects to my children not to mind all three, the stress associated would be unthinkable.

My children find it very difficult to sleep and are [REDACTED] regarding same.

I Cannot afford any sleep disturbance as it will have huge implications

My children must have structure and routine, and every day must be the same in their home environment.

Please read and understand my fear and worry for my 2 [REDACTED] boys and my child with [REDACTED] as well as all the rest of my family .

Uncertainty is something we do not have on our agenda.

Please feel free to contact me regards my serious concern for my family.

Grounds for Objection

1 . Shadow Flicker / Noise/ Visual impact /Health concerns.

The shadow Flicker as caused when sun shines at back of the turning blades would have a Serious effect on the health of my 2 [REDACTED] boys and my child with [REDACTED] .

Noise – both low / high pitch would have a massive effect on the sleep pattern of my children Who presently are [REDACTED] sleep –

These Enormous 170M high wind Turbines with a turning diameter of 150 M just over 1Km From my house would appear like monsters to my children.

Health Concerns- Any one of the above three issues would have a serious effect on my Children not to mind all three – the stress it would cause all my family would be unthinkable.

2.Inadequate Public Consultation and Transparency.

There has been insufficient engagement with the local community on the proposed erection of these enormous 9 wind turbines and associated ground work . Many if not most of the local community were not adequately informed nor given an opportunity to participate in the consultation process .

3. Property Devaluation.

A Study by university Galway on properties adjacent to Wind Turbines suggests there may be a devaluation of as least 14% . This would have a serious implication for my dwelling as well as all properties adjacent to the proposed Garrane wind Farm .

Conclusion .

For the reasons above and in particular for the health and wellbeing of my two [REDACTED] boys
And my child [REDACTED] I respectfully request that An Bord Pleanála refuse planning
permission for the Garrane Wind Farm development.
