The first forms were signed up in 2021, and yet the community consultations only started in 2025, which means we were kept in the dark for at least 4 years.

If Garrane Green Energy were serious about getting our concerns and imput as a community they would have started consultations in 2021. It wasn't even announced publicly until 2025.

Regular winter flooding near the River Loobagh and the River Maigue in Ballinagoul, and now we have concerns of more severe flooding on our farmland due to the construction of a wind farm on Flood Zone A. As there is already up to 25 acres flooding during heavy rains.

Construction traffic going through an already busy town Charleville. In the last few years there has been several fatalities in Charleville with articulated lorries passing through the town. Construction traffic will also be going through the small village of Bruree.

Massive change to our local landscape mapping being imposed on us without our approval.

We are living here in Ballinagoul for the last 40 years and we regularly see ducks, geese and swans flying overhead towards the Charleville lagoons. We are deeply concerned with the impact these turbines will have on bird life, given that they will be directly in their flight path. We fear that Garrane Green Energy underestimated the impact on wet land birds, particularly those coming from the North East ie. Lough Gur direction.

Trees will have to be cut down. This development will substantially harm wild life and hedgerows, and destroy habitats. It will change our landscape and community far more than we were first led to believe.

Devaluation of properties.

Planning restrictions mean no new houses can be built within a certain distance from a turbine, yet these huge turbines may be permitted beside houses that already exist.
