Order:- Having considered and approved the reports of the Senior Engineer, A/Senior Executive Engineer and Senior Planner it is hereby ordered that:-

- (1) the lands outlined in Red on the attached map titled: 'Compulsory Purchase Order Map - Sligo City Campus Regeneration Project' details of which are set out in the Schedule hereto be acquired compulsorily in pursuance of the powers conferred on Sligo County Council by Section 76 of and the Third Schedule to the Housing Act 1966 as extended by Section 10 of the Local Government (No. 2) Act 1960 (as substituted by Section 86 of the Housing Act 1966) and amended and extended by Section 6 and the Second Schedule of the Roads Acts 1993 and amended by the Planning and Development Acts 2000 to 2018 and in particular by section 222 of the Planning and Development Acts 2000 to 2018 and in exercise of the powers conferred on it by the above mentioned legislation and in particular section 213 of the Planning and Development Act, 2000 (as amended).
- (2) the Compulsory Purchase Order be titled:

Sligo County Council Compulsory Purchase (No. 01) Order 2025.
Sligo City Campus Regeneration Project
Lands at Nos. 10,12,13,14,15, and 67 Holborn Street
- (3) the common seal of Sligo County Council be affixed to the aforesaid Compulsory Purchase Order and the maps attached thereto.
- (4) the statutory notices prescribed by the Housing Act, 1966 (Acquisition of Land) Regulations, 2000, and the Housing Act, 1966 (Acquisition of Land)

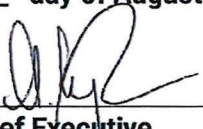
