We refer to your correspondence dated 13th November 2025, inviting Clare County Council to make a submission on the six observations received by An Coimisiún Pleanála in relation to the above proposed development, with a response deadline of 11th December 2025.

The Project Team have reviewed the submissions received, including those from local residents (Mr Pat Tierney, Mr Robert Behan, and Mr Dermot Queally), prescribed bodies (Uisce Éireann, the Development Applications Unit of the Department of Housing, Local Government and Heritage), and the technical submission from Mr Michael Duffy, and from our review it is evident that the issues raised require a comprehensive multi-disciplinary response.

Accordingly, Clare County Council formally request an extension of time of two months (including the period over Christmas), to **20th February 2026**, to allow our Project Team to prepare our response submission.

We trust that the Commission will consider this request favourably in the interests of clarity, completeness of information, and the proper assessment of the issues raised under Section 177AE.
