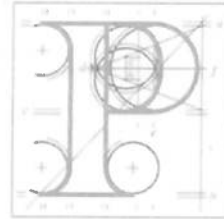

Dear Secretary,

I wish to make the following submission/observation with regard to above application. My family home is very close to above development and I have grave concerns about the possibility of potential/further flooding of my lands from proposals submitted. Over the years there has been various works going on at the graveyard including drainage works etc but it has never fully addressed the issue of flooding of my lands and in particular the area around my septic tank. All these problems can be directly traced back to the inability of existing stormwater drainage from graveyard being contained and dispersed of adequately within its own bounds. Indeed the current method uses existing drains which have not got the capacity to manage same. This leads to overflow of drains, flooding to public road and egress on to my lands around septic tank. Naturally this should be of concern from a public health issue. This was never an issue before recent works to graveyard and I feel, notwithstanding new proposed soakpits, that it will never be addressed unless flooding causes an incident to public road/traffic etc. I hope the Coimisiun would bring to bear some pressure on Clare Co Co to further insure that design of drainage proposals adequately address my concerns and help alleviate/stop flooding to my lands.
