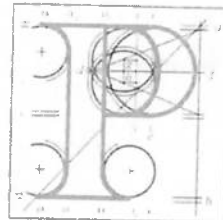

I wish to make the following submission/observation with regard to above application.


I live in my family home close to above development and wish to voice my concerns about the impact said development would have on my property mainly from a stormwater/ground water view.

There has been various ongoing works at the graveyard over a number of years be it landscaping/improvements/drainage etc and this has lead to hereto unknown flooding issues mainly to public road that has directly affected my property. I am fearful that if this issue is not resolved it may lead to flooding of my dwelling and public road adjacent with associated traffic safety concerns.

I must state that I am not against the proposed development in any way and I appreciate from viewing proposed design drawings , that Clare County Council are trying their utmost to facilitate concerns re: flooding. I note the inclusion of two new soakpits but would still have worries about its capacity to cater for the sheer volume of storm water etc as our weather systems are now producing wetter and wetter seasons.
