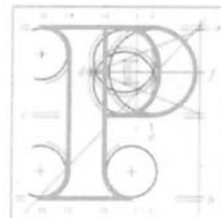

Dear Secretary,

I wish to make the following submission/observation with regard to above application. I live in my family home adjacent to above development on family farm/landholding that has been in my family for generations and while i am not opposed to extending the graveyard i have serious concerns especially with regard to drainage and storm water disposal connected to the development. In recent years any work undertaken at graveyard has led to flooding of public road adjacent my dwelling and indeed my farmlands so much so that i had to install a pumping system to take away flood water from my lands to an exit point uphill and across my lands to a safe non-impactful area. It should be noted that i have had to do this at considerable expense to myself and that this flooding to my property was never an issue until recent times and due to continuous work around graveyard. I also note that application is proposing 2 No soakaways but can this guarantee adequate and sufficient disposal of stormwater/ground water etc and prevent flooding to my property and indeed, public road with its associated public safety issues. I cannot keep incurring financial burdens to keep flooding out of my property due to circumstances not of my making.
