**Re: 10 year planning permission for Ballinlee Wind Farm consisting of 17 no. wind turbines, a permanent 110kV substation and ancillary development. Located in Ballincurra, Ballingayroure, Ballinlee North & South, Ballinrea, Ballyreesode, Camas North & South, Carrigeen, Knockuregare, Ballybane and other townlands in County Limerick.**

To Whom It May Concern,

I Alice Hennessy, write in connection with the above listed planning application at Ballincurra, Ballingayroure, Ballinlee North & South, Ballinrea, Ballyreesode, Camas North & South, Carrigeen, Knockuregare, Ballybane and other townlands in County Limerick.

I wish to object strongly to this proposal and ask that the Board refuse planning permission.

Some of my summarised observations and concerns are as follows:

I am very worried about shadow flicker as I am a chronic sufferer of migraine and the turbines lie to the south west of my home. I was not included in the shadow flicker study. Also, as a migraine sufferer, I am worried about the construction noise and vibration which will be within 400 metres of my home.

I object to the visual intrusion on my view of this unchanged rural landscape. As a low lying rural community Ballinlee had a right to expect that our landscape would not be turned into an industrial park. I bought my home 13 years ago and for reasons associated with my provenance and health. This wind farm will rob me of that.

All my neighbours and members of this community that I have spoken to are against this wind park.

My amenity will be destroyed by the construction traffic for two years.

I will be prevented from using my road to go to work during the height of the construction.

I am not sure I will be able to stay in my home when this industrial project is in construction and operation and I am not sure I will be able to sell it.

The site of some of the turbines is a corcass (marsh) which is currently flooded almost level with the road. If turbines are constructed in this area, it will displace more water onto the area already flooded and make the road impassible during wet weather for prolonged periods.

I strongly urge that this development be rejected for the reasons outlined above.

I request that for an Oral Hearing in relation to this wind farm application, for the reasons outlined above. In particular the proximity and impact this will have on Lough Gur, an architectural and archaeological site of international importance, and the impact on our Golden Vale's High Value Landscape. Furthermore the scale of the project and the pattern of population distribution which will have widespread impact on our local community.
