Planning permission was granted under the Planning Acts to Terenure Housing Limited for a residential development at The Dunes, Portmarnock, County Dublin. The planning permission contained a condition requiring for the provision of land as open space and it was either explicit or implicit in the planning application that the land would be provided as open space. Chief Executive Order P Env/391/87 authorised the acquisition of open space lands at The Dunes, Portmarnock, County Dublin on the foot of a Deed of Dedication submitted by Terenure Housing Limited.

Fingal County Council, in its capacity as a Planning Authority, has previously served a written request for the open space lands at The Dunes, Portmarnock, County Dublin to be provided to the Council, however the open space lands have yet to be transferred to the Council.

It is now recommended that the procedure pursuant to Section 45 of the Planning and Development Act 2000 (as amended) be initiated to vest the open space lands at The Dunes, Portmarnock, County Dublin in the ownership of the Council, that an acquisition notice be published in a newspaper circulating in the district of Fingal, that a copy of the acquisition notice be served on the owner(s) of the lands described and that an application be made to An Coimisiún Pleanála to confirm the acquisition notice in order to vest the lands, as shown delineated in red on Drawing Index No. 5552 in the ownership of Fingal County Council.

I concur with the above and recommend payment of the Council's costs in this matter together with any additional approved costs that may arise and that in accordance with the provisions of this Order and subject to confirmation of the acquisition notice, the Council is hereby authorised to commence the statutory procedures to vest the said lands in the ownership of the Council for the purpose outlined above.

- 2. The consideration for such agreement shall be the sum of £1 (one pound).
- 3. The Grantor shall within 21 days from the date of this Agreement furnish to the Council or their Solicitor (and at the expense of the Council) evidence proving the sitle as owner in fee simple free from incumbrances of the said strip or parcel of land.
