Temporary spaces at car park

As part of the on-going €15m redevelopment of Balbriggan's Quay Street and Harbour, 15 car parking spaces are being temporarily removed at Mill Street Town car park, bringing the number of spaces available to 52, writes Rose Barrett. Local councillors remind that the spaces will be in use on a temporary basis by the contractor, and will be available to the public again on December 1, 2025. This is to allow site investigations at the adjacent brownfield site. It is anticipated the flagship plaza project at the Harbour will be substantially completed in spring 2026.

Pop-up shop for the Red Cross in Gaza

As part of an ongoing drive to raise funds for the besieged people of the war ravaged Gaza, Aontú's Cllr Ellen Troy is organising a one-day pop-up shop in Castleknock Tennis Club.

Cllr Troy says: "It is utterly heart wrenching to see the pain and suffering that the unfortunate civilians of Gaza have to endure. Words really can't give full expression to how I feel about the situation. It is horrific to see so many tens of thousands of civilian lives lost and destroyed and changed irreparably."

"These are human beings, just like you and me, and they are forced to have to endure the most appalling, unjust and indiscriminate suffering. Children are dying, elderly people are dying, ordinary people have to scramble for meagre rations of food, others are dying of starvation, the catalogue of injuries is horrendous; it is beyond comprehension, and it is inhuman."

Rather than feel helpless and hopeless, she decided to organise this one-day event where people from all over D 15 can donate their once loved and quality used clohh-

ing and accessories, which will raise funding for the Irish Red Cross who are doing such wonderful humanitarian work in Gaza.

"We all have clothes in our wardrobes that we are either tired of, have never worn or bought on a whim and wish to get rid of, and this 'Pop Up and Shop for Palestine' is the perfect opportunity to do that."

She says that she has been inundated with donations of clothes and promises some real treasures on the day.

"People are just so good, so generous. They are watching the horrendous scenes of human misery on their television screens night after night and have really come on board for this pop-up shop. They have given me fabulous items for sale, and I can't wait to see the reaction from people on the day."

Every single cent raised will go to the Irish Red Cross and it is a real opportunity for the people to show solidarity with the suffering people of Gaza.
