
I, John Hehir, address: Glencanane, Kildysart, Co Clare. V95 KC63, wish to formally object to the proposed Cloonkett Wind Farm Development at Cloonkett and Burrenfadda, County Clare.

It should be noted that while I am not against wind energy in principle I think the location of same should be given more consideration regarding its impact on the landscape and local population.

As you can see from attached maps, the development will be quite close to my landholding, Folio CE 20932, at a location where my daughter intends to renovate and extend existing derelict cottage for her future permanent place of residence. This will lead to dwelling being in an extremely close and disconcerting proximity to hugely overbearing windmills with its associated noise and flicker implications. Consideration should be given to relocating some proposed adjacent windmills away from area adjacent my derelict cottage.

I trust my concerns re: development will be taken on board and given a thoughtful and sympathetic consideration that it deserves.


