**Re: Application under Section 177AE of the Planning & Development Act 2000 as amended
to undertake the Newtownmoyaghy Road Improvement Scheme**

Dear Sir/Madam,

Meath County Council wish to apply under Section 177AE of the Planning & Development Act 2000, as amended, to carry out development in the form of a Road Improvement Scheme at Newtownmoyaghy, Kilcock, County Meath.

The development consists of the following:

- diversion of the Newtownmoyaghy Stream within an area of agricultural grassland to the northeast of the existing channel and road;
- piping, infilling and topsoiling of the existing stream channel;
- provision of new culvert under the Newtownmoyaghy Road to connect the diverted stream into the existing channel downstream;
- provision of agricultural crossings over the new channel;
- widening of the existing carriageway;
- construction of new road pavement and upgrade of existing road pavement;
- alterations to the entrance of one residential property;
- provision of new agricultural entrances; and
- provision of associated drainage infrastructure, boundary treatments, surfacing works, road marking, traffic signage and landscaping.

A Natura Impact Statement (NIS) has been prepared in respect of the proposed development.

We attach:

- 3 copies of the plans and particulars including the NIS of the proposed development (2 hard copies and 1 soft copy);
- a copy of the notice published in the Leinster Leader newspaper under Section 177AE(4)(a); and
- a list of the bodies to which the notice was sent under Section 177AE(4)(b), and a dated copy of each notice issued.

We now seek formal approval to carry out this development at Newtownmoyaghy, Kilcock, County Meath.
