Introduction

Pursuant to Section 177AE of the Planning and Development Act 2000 (as amended) and the requirements of the Planning and Development Regulations 2001 (as amended), notice is hereby given that Meath County Council proposes to make an application for approval to An Coimisiún Pleanála for the proposed Newtownmoyaghy Road Improvement Scheme, at Newtownmoyaghy Road, Kilcock, Co. Meath.

Description of the Proposed Development

This Section 177AE application to An Coimisiún Pleanála is in relation to the proposed Newtownmoyaghy Road Improvement Scheme. Meath County Council are proposing to upgrade and widen the existing Newtownmoyaghy Road which will result in the diversion of the Newtownmoyaghy Stream to the northeast of the existing channel and road, within an area of agricultural grassland.

Compaction from traffic and erosion from stream flood events has caused the existing road edge and verge to collapse in discreet sections into the Newtownmoyaghy Stream (EPA Code:09N02; (also known as the Jenkinstown Stream), which is a tributary of the WFD waterbody Rye_Water_020 [WFD code: IE_EA_09R010300]) which runs adjacent to the road.

This has become both a health and safety risk for road users and an environmental risk due to the release of hydrocarbons and other vehicle pollutants entering the adjacent stream via run-off. To resolve the issue, Meath County Council propose to carry out an open channel diversion and infilling of the existing stream in order to facilitate the widening of the road and road verge.

The proposed development will consist of:

diversion of the Newtownmoyaghy Stream within an area of agricultural grassland to the northeast of the existing channel and road

- piping, infilling and topsoiling of the existing stream channel
- provision of new culvert under the Newtownmoyaghy Road to connect the diverted stream into the existing channel downstream
- provision of agricultural crossings over the new channel
- widening of the existing carriageway
- construction of new road pavement and upgrade of existing road pavement
- alterations to the entrance of one residential property
- provision of new agricultural entrances; and
- provision of associated drainage infrastructure, boundary treatments, surfacing works, road marking, traffic signage and landscaping.

The Natura Impact Statement (NIS)

The purpose of the NIS report is to evaluate whether the project, individually or in combination with other plans and projects, would have an adverse effect on the integrity of any European site, in view of that European site's conservation objectives and in view of the best available scientific knowledge.
