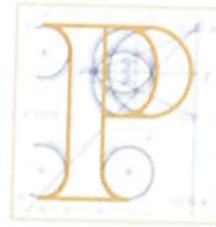

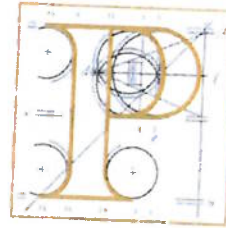

Dear Sir / Madam,

An Coimisiún Pleanála has received the further information requested by it in relation to the above-mentioned proposed development.

As the Commission considers that this further information contains significant additional data in relation to the likely effects on the environment of the proposed development, the likely consequences for proper planning and sustainable development in the area in which it is proposed to situate the said development, and the likely significant effects of the proposed development on a European site, it hereby requires you in accordance with section 177AE(5)(d) of the Planning and Development Act, 2000, as amended, to –

- (a) Publish in one or more newspapers circulating in the area in which the proposed development would take place a notice stating that significant further information in relation to the said effects has been furnished to the Commission, that the further information will be available for inspection or for purchase (on payment of a specified fee not exceeding the reasonable cost of making a copy) at a specified place and at specified times during a specified period, and that submissions or observations in relation to the further information may be made in writing to the Commission before a specified date, and
- (b) Send notice of the furnishing to the Commission of significant further information, and a copy of the further information, to the bodies and persons referred to in section 177AE(4)(b) and to indicate to such bodies and persons, that submissions or observations in relation to the further information may be made in writing to the Commission before a specified date.

In respect of (a) above, the notices should be published in the same newspapers in which notices of the original application were advertised and the further information should be made available for inspection or purchase at the same locations at which the original application documentation was available. In respect of the time limits for the making of submissions or observations in relation to the further information to the Commission under (a) and (b) above, please indicate the specified time limit for the receipt of submissions to be no less than 3 weeks from the date of publishing said notice.

You should submit the relevant newspaper notices and a copy of any notices issued under (b) above to the Commission as soon as same are available.

Your response to this letter should be received on or before 18th June 2026.

You are welcome to submit a draft notice to the Commission for review prior to publication.
