I hope you are keeping well.

I am writing in relation to the proposed Crumhach Wind Farm in Co. Sligo. We recently received the meeting minutes regarding the Opinion on unconfirmed details to be included in the application. I understand that the record will not be amended, however, I wish to clarify the following points for the record:

- The minutes (page 2) state that the meeting took place under Section 182G of the Act. For clarity, the meeting was held under Section 37CC of the Act.
- The minutes (page 3) refer to incorrect turbine parameters in respect of the design flexibility sought. An updated presentation and accompanying cover letter were issued by email on 3rd December to reflect the correct parameters. For the avoidance of doubt, the turbine ranges to be sought are as follows:
 - Total tip height: 176.6m – 180m
 - Rotor diameter: 133.2m – 150m
 - Hub height: 105m – 110m

Please let me know if any further clarification is required.
