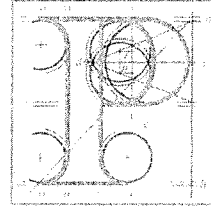

In relation to the above matter, this is to acknowledge receipt of your letter of the 3rd inst

I wish to make the following observations on the comments of the Local Authority.

Title and Debt on the Property

Leasehold Folio – Apartment No. 8

The property is comprised in Folio CB2222I, and it is accepted that Michael Kennedy and Margaret Mulvihill still appear on the Folio as registered owners.

As previously advised to the Council, my late husband, Anthony J. Fitzpatrick, purchased the property in 2010 for an amount equivalent to the redemption figure on the mortgage. Since that date, we have been in undisputed possession of the property and in receipt of the rents and profits therefrom.

In those circumstances, my late husband became the beneficial owner of the property and as the sole beneficiary of his estate, I became the beneficial owner of the property on the date of his death. Furthermore, on redemption of the mortgage, the title documents were delivered to my late husband's agent, which confirms our legal interest in the property.

Objection to Acquisition by CPO

On the notes under this heading, at 28.8.2005, it is stated "The Council wrote to Ms. Kennedy ...". This is a typographical error and should read "Ms. Fitzpatrick". The definition of owner in Section 15 of the Derelict Sites Act 1990 is not a legal definition of ownership and is therefore limited in its application. Section 15(2), this section does not apply to this property, as it refers to "...being entitled to dispose of the fee simple...". The title to this property is Leasehold and is therefore, not fee simple. In such circumstances, the Local Authority cannot rely on Section 15(2). Furthermore, this section of the Act also states "...and includes also a person who holds or is entitled to rents and profits...". My late husband and I have been in receipt of the rents and profits of the property for upwards of fourteen years.

The fact that I am not the registered owner does not preclude me from ownership. As set out above, I am the beneficial owner of the leasehold interest in the property.

1. Comment from Clare County Council

- a. With respect, the Council are not in a position to comment on the occupation of the property since 2010. They then make reference to "They own their own house...". This comment is not relevant. When I say that we were in occupation of the property, I mean that in the legal sense, that we were in undisputed possession of the property and were therefore in occupation in that sense. It has not been vacant for many years.
- b. It has been occupied since it was acquired by my late husband. It was occupied by a tenant, namely Theresa McDonald and her five children from 2006 to 2010 at a monthly rent of €250.00. I attach a photograph, taken in the apartment whilst she was in occupation. See letter of Theresa McDonald attached. It was occupied by another tenant, namely Marek Kepa from 2010 until the date of his death on the 1st November 2023. As evidence of tenancy, I attach proof of his address, to include Vodafone account, Electric Ireland account, HSE Medical Card and Specsavers letter. I also attach copy text messages between Marek Kepa and myself, which make reference to rent and occupation from 2019 to 2022.
- c. The property was let prior to the existence of the PRTB.
- d. The point made here by the Council is not correct. The agreement to acquire the property, was to acquire for an amount equivalent to the amount of the redemption figure of the mortgage.
- e. There is ample evidence that the agreement was concluded, as the loan was redeemed and the title documents were forwarded to my late husband.
- f. Section 15 of the Derelict Sites Act 1990 deals with the procedure taken by the Local Authority and their Notice of Intention to acquire derelict sites compulsorily. This section does not deal with objections.

Section 16 of the Act deals with objections to compulsory acquisition of derelict sites. Section 16(1) provides "any other persons upon whom notices of the proposed compulsory acquisition of a derelict site have been served, may, ...". As a notice party, I am entitled, under the provisions of the Act, to make an objection. It seems the County Council, in their comments, have conflated Section 15 and Section 16.

2. Comment from Clare County Council

- a. It is open to me to make an application to Tailte Eireann for title based on possession at any point.
- b. In relation to documentary evidence, please see earlier comments. I would remind you that we have been in possession of the title documents for upwards of fourteen years.
- c. It is noted that a copy of the Notice was sent to me and as outlined above, I am therefore entitled to make an objection.
- d. It is open to me to make an application to Tailte Eireann at any point.
- e. Stamp Duty can be paid at any time, subject to payment of interest and penalties.

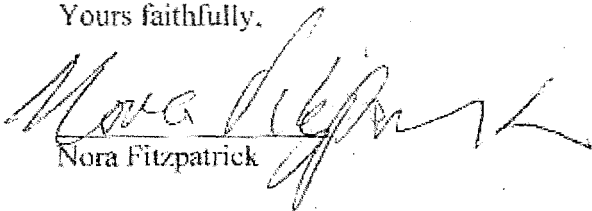
3. Comment from Clare County Council

- a. It is not agreed that the property is a derelict site under the provisions of the relevant legislation. It is noted that the Council make reference to a report in June 2025, but I have not been provided with a copy of same.
- b. The person, namely Marek Kepa, occupied the apartment up until the time of his death on the 1st November 2023. I attach letter of An Garda Siochana. He was in fact a tenant – see comments and documents provided above. I never made any reference to squatting and I never said "...he had squatted in the apartment...". I did make reference to the poor conditions, but this was a reference to the unkempt manner in which he kept the apartment and the conditions in which he lived.

I request An Coimsium Pleanala to refuse the compulsory acquisition of this site for the following reasons:

- I. The property is not derelict.
- II. The property has not been derelict for many years. See evidence provided above. I am, and was available at all times to engage with the Local Authority to solve any issues the Council may have with the property.
- III. Sufficient evidence has been provided and is available to show that I am the beneficial owner of the leasehold interest of the property by virtue of undisputed occupation, memorandum in writing, payment of consideration and possession of title deeds, which were handed over to my late husband by First Active Building Society, who held the mortgage on the property.
