1. Introduction

Please find enclosed Laois County Council's (LCC) application, under Section 175 and Section 177AE of the Planning and Development Act, 2000 (As Amended) (hereafter referred to as "the Act") for approval of a proposed flood relief scheme in Mountmellick, Co. Laois. Laois County Council (LCC), in conjunction with the Office of Public Works, are proposing the scheme for Mountmellick to address the risk posed by fluvial and pluvial flooding. The proposed planning submission relates only to the construction of fluvial and pluvial flood defence assets.

Accordingly, under Section 175 and Section 177AE of the Act, LCC considers that it is required to apply to the Board for approval.

The FRS will comprise of a series of walls and embankments along the Owenass, Clontygar, Pound and Garroon rivers, a surface water pumping station, the realignment of a limited length of the Clontygar, the reconstruction of Owenass Bridge, the provision of a demountable flood gate at Convent Bridge, the provision of several culverts and the removal of vegetation.
