The proposed development consists of the construction of a new Footbridge and resurfacing of existing lane with walkway link to the existing park in the form of new footpaths and all ancillary site works as required to complete the works at Newport Ball Alley and Park, Newport, Co Tipperary.

Pursuant to the requirements of Section 177AE of the Planning and Development Act 2000 (as amended) and the Planning and Development Regulations 2001 (as amended), notice is hereby given that Tipperary County Council proposes to seek approval from An Coimisiún Pleanála for the proposed development of the construction of a new Footbridge and resurfacing of existing lane with walkway link to the existing park in the form of new footpaths and all ancillary site works as required to complete the works at Newport Ball Alley and Park, Newport, Co Tipperary.

The footprint of the proposed project is within a Special Area of Conservation, namely Lower River Shannon SAC – 002165.

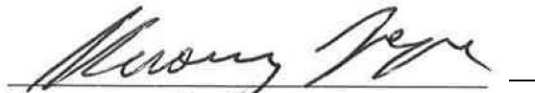
In relation to the proposed development, An Coimisiún Pleanála may give, approval to the application for development with or without conditions, or may refuse the application for development.
