RE: Application for Approval made under section 177 (AE) of the Planning Development Act 2000 (as amended) for the Newport Ball Alley Footbridge, Newport, Co. Tipperary

A Chara,

Tipperary County Council wish to apply for approval under section 177AE of the Planning and Development Act 2001 (as amended) for the Newport Ball Alley Footbridge, Newport, Co. Tipperary.

The proposed development consists of the construction of a new Footbridge and resurfacing of existing lane with walkway link to the existing park in the form of new footpaths and all ancillary site works as required to complete the works. The footprint of the proposed project is within a Special Area of Conservation, namely Lower River Shannon SAC – 002165.

A Natura Impact Statement (NIS) has been prepared in respect of the proposed development.

An Environmental Impact Assessment (EIA) screening determination has been completed by Flynn Furney in support of this application. The EIA screening determination has been informed by the Natura Impact Statement prepared by Flynn Furney Consultants which is included as part of the plans and particulars forming this submission.

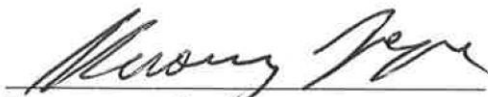
