We refer to your letter dated 12th February (received 16th February) and the enclosed submissions / observations from the Notified Bodies.

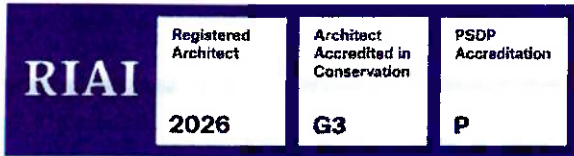
