

**Planning and Development Act 2000, as amended  
Notice of Direct Planning Application to An Coimisiún Pleanála  
Strategic Infrastructure Development  
Kilkenny County Council**

In accordance with Section 182A of the Planning and Development Act 2000, as amended, we, Manogate Ltd., intend to apply to An Coimisiún Pleanála for approval for development at this site comprising proposed grid connection options (GCO) One and Two to connect to the proposed Ballyfrasy Wind Farm, in Co. Kilkenny. GCO One spans across the townlands of Ballymartin, Bishopsmountain, Smithstown, Ballymackillagilly, Gienpipe, Mullenkilly, Coolnahau, Cappagh and Castlebrany, Co. Kilkenny. GCO Two will be located across the townlands of Ballymartin, Ballyfrasy Upper and Ballywally, Co Kilkenny, within the proposed Ballyfrasy Wind Farm site (not part of this application).

Certain details of the proposed development are unconfirmed in this planning application and an opinion on unconfirmed details from the Commission (Case Reference: ACP-322293-25) pursuant to section 182G of the Planning and Development Act 2000 (as amended) accompanies this planning application. The details unconfirmed in this application relate to the proposed grid connection type and route and are specified on this site notice and in the design flexibility opinion that accompanies this application.

The proposed development will consist of one of the following Grid Connection Options (GCOs):

- 0 **GCD One: Gcd connection to the consented Castlebanny Wind Farm substation:**
- 0 Circa 12 km long 110 kV underground cable grid connection to the consented Castlebanny Wind Farm (ACP Ref. PA10.309306)
- 0 substation consisting of 6 No. ducts in an excavated trench to accommodate 3 No. power cables, 1 No. fibre communications cable, 1 No. spare fibre communications cable and 1 No. earth continuity duct where required, Joint Bays, Communications Chambers, and Earthing Link Boxes.
- 0 1 No. Temporary Construction Compound.
- 0 1 No. Temporary Spoil Deposition Area.
- 0 All related site work, horizontal directional drilling under watercourses and bridges, road and grid crossings, drainage and ancillary works.

**GCO Two: Proposed loop-in grid connection to existing Great Island-Kilkenny 110 kV overhead line:**

- 0 Decommissioning of a portion of an existing 110 kV overhead line and pole set on the Great Island-Kilkenny overhead line.
- 0 2 No. New 110 kV Overhead Line Cable Interface towers.
- 0 Two 110 kV underground cable circuits, comprising approximately 4.6 km of cabling (two circuits of 2.3 km each), will be installed from the line-cable interface mast to the proposed Ballyasy 110 kV substation (not part of this application). Each Circuit will consist of:

- 6 No. ducts in an excavated trench to accommodate 3 No. power cables, 1 No. fibre communications cable, 1 No. spare fibre communications cable and 1 No. earth continuity duct where required, Joint Bays, Communications Chambers, and Earthing Link Boxes.

- o An access road will be provided to facilitate permanent access to the underground cable route between the interface mast and the proposed onsite 110KV Ballyfrasy substation.
- o All related site work, horizontal directional drilling under 1 no. watercourse, drainage and ancillary works.

A separate Strategic Infrastructure Development planning application for the proposed Ballyfrasy Wind Farm development has been submitted to An Coimisiún Pleanála. This application, and the proposed Ballyfrasy Wind Farm application are functionally interdependent and constitute a single project. The proposed wind farm development comprises the erection of 10 no. wind turbines, the construction of 1 no. permanent on site 110 kV electrical substation, new internal site access roads, the erection of 1 no permanent 100 m tall meteorological mast and other associated works. The proposed wind farm and related works are located within the townlands of Ballywaity, Bishopsmountain, Knockbrack, Ballymartin, and Ballyfrasy Upper, Co. Kilkenny.

A 35-year operational period from the date of full commissioning of the wind farm is being sought for all works (other than temporary and permanent works specified above), and the subsequent decommissioning. The proposed onsite substation and grid connection will remain permanent infrastructure and form part of the Irish national grid network.

Both applications are accompanied by one Environmental Impact Assessment Report (EiAR) and a Natura Impact Statement (NIS), which pertain to the overall project.

The planning application, including the EIA<sup>2</sup> and NIS, may be inspected, free of charge or purchased for a specific fee not exceeding the reasonable cost of making a copy, during public opening hours for a period of 7 weeks plus an additional statutory holiday period of 9 days commencing on 19th December 2025 at the following locations:

Submissions or observations may be made only to An Coimisiún Pleanála (The Commission), at 64 Marlborough Street, Dublin 1, D01 V902 in writing or online on the Commission's website [www.pleanala.ie](http://www.pleanala.ie) during the aforementioned period of 7 weeks plus an additional statutory holiday period of 9 days relating to: (i) the implications of the proposed development for proper planning and sustainable development of the area concerned; (ii) the likely effects on the environment of the proposed development if carried out; and (iii) the likely significant effects of the proposed development on a European site, carried out.

Any submissions or observations must be accompanied by a fee of £50 (except for certain prescribed bodies), and must be received by the Commission not later than **5.30pm on the 16th February 2026** and must include the following information: (i) The name of the person making the submission or observation, the name of the person acting on his or her behalf, if any, and the address to which any correspondence relating to the application should be sent; (ii) the subject matter of the submission or observation; and (iii) the reasons, consideration and arguments on which the submission or observation is based in full. Any submissions or observations which do not comply with the above requirements cannot be considered by the board.

The Commission may, in respect of an application for permission decide to – (a); (i) grant the permission, or (ii) make such modifications to the proposed development as it specifies in its decision and grant permission in respect of the proposed development as so modified or (iii) grant permission in respect of part of the proposed development (with or without specified modifications of it of the foregoing kind), or (b) refuse to grant permission. The decision to hold an oral hearing on this planning application is at the absolute discretion of An Coimisiún Pleanála.

Any person may question the validity of any such decision of the Commission by way of an application for judicial review, under Order 84 of the Rules of the Superior Courts (S.I. ## PLANNING APPLICATIONS

Louth County Council: Ge Energy Ltd intend to apply 10 Year Planning Permission for a Battery Energy Storage System and underground cabling grid connection to existing Drydock 1 substation in the Trowan Well and Lilliallen, Drogheda Co Louth. The proposed development will comprise no, commercialised-energy storage modules, 6 no. twin transformers, 2 no. space heating, security and landscaping, drainage and associated development works apparatus necessary to facilitate the proposed development. Planning permission is sought for 1 no. 38kV substation associated electrical compartment, including single story, C building, line bay, transfer and accompanying apparatus and associated grid connection. The proposed substation and Drybridge 1 underground electricity cable of c.1.3km in length is provided in an excavated trench on private lands and the L6 R166, N51 and L2322 roads, and all associated development and reinstatement works. Construction operation access to the B Energy Storage System will be via the L63324 off R166 road. A Natura Impact Statement (NIS) has been prepared and will be submitted to the Planning Authority for the application. The NIS is available for inspection purchase at a fee not exceeding the reasonable cost of making a copy during office hours at the offices of the Planning Authority. The planning application may be inspected, or purchased at not exceeding the reasonable cost of making a copy, at the offices of the Planning Authority during its public opening and a submission or objection in relation to the application may be made to the authority in writing, on payment of prescribed fee within the first 5 weeks beginning of the date of receipt by the authority of the application.

Further, Tipperary County Information/Revisions Ltd. (Fartane) has submitted the plans for development at Gurtene Garraire, Templeeny, Ne Co. Tipperary, in relation to planning reference number 25146, that significant information/ revised plans in relation to the application have been furnished to the Planning Authority, and are available for inspection or purchase at not exceeding the reasonableness of making a copy of the plans for the public offices of the Authority at public opening hours, at a cost of making a copy of the plans for the public submission or observation relation to the significant information/ revised plans to be made in writing to the Planning Authority on payment of the prescribed fee, not more than 2 weeks after the receipt of the plans by the newspaper and site notice by the planning authority.
