

Please see Donegal County Councils response to the observations received from Uisce Éireann relating to our application (ACP-323960-25).

1. Donegal County Council will engage with Uisce Éireann prior to the commencement of the development and adhere to the standards and conditions set out in that agreement.
2. No structures are planned to be built over public infrastructure and separation distances as per Uisce Éireann's Standards Codes & Practices will be adhered to.
3. The proposed development is not located adjacent to any known public drinking water sources and/or abstraction point(s) and/or abstraction infrastructure and will not impact on such.
4. The design and construction of the water & wastewater pipes and related infrastructure associated with the development will be in full compliance with Uisce Éireann Connections and Developer Services Standard details and Codes of Practice.
