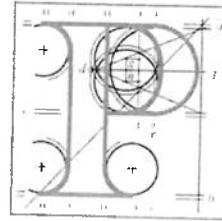

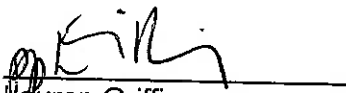
In due course, a refund for the fee that you have paid will be issued to the debit/credit card used to make the payment.
