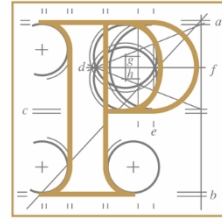

I have been asked by An Coimisiún Pleanála to refer further to the above-mentioned pre-application consultation under section 37CC of the Planning and Development Act 2000, as amended.

Please note that the public will have the right to make submissions / observations on the application only to An Coimisiún Pleanála and within a time limit which will be specified in the public notices (copies of same will accompany the application documentation) and the public should be alerted to this fact when inspecting the file. It is the Commissions intention that all of the application documentation will remain available for public inspection during the currency of the application.
