Re: Planning and Development Acts 2000 (as amended) Notice of Direct Planning Application to An Coimisiún Pleanála in respect of a Strategic Infrastructure Development, Carrigeen Wind Farm, Co Roscommon.

Dear Sir / Madam,

The applicant should be required to engage with Ireland West Airport and the air navigation service provider, AirNav Ireland, to confirm that the proposed wind farm development including cranes used during its construction, will have no impact on Instrument Flight Procedures at Ireland West Airport, or on Communications, Navigation and Surveillance (CNS) equipment at the aerodrome and en-route CNS equipment operated and maintained by AirNav Ireland. In the event of planning consent being granted, the applicant should be conditioned to contact the Irish Aviation Authority to:

- (1) agree an aeronautical obstacle warning light scheme for the wind farm development,
- (2) provide as-constructed coordinates in WGS-84 format together with ground and tip height elevations at each wind turbine location and:
- (3) notify the Authority of intention to commence crane operations with at least 30 days prior notification of their erection in accordance with S.I 215 of 2005 Irish Aviation Authority (Obstacles to Aircraft in Flight) Order.
