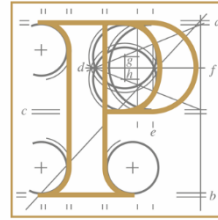

The pre-application consultation file already sent to you must be associated with the application file documentation. It is the Commission's intention that all of the application documentation will remain available for public inspection during the currency of the application.

Written submissions in relation to the proposed development should be made directly to An Coimisiún Pleanála. Two copies of any written submissions received in relation to the application will be forwarded by the Commission to your offices. You are requested to make available for public inspection a copy of the submissions. Please be advised that a fee of €50 is payable to the Commission in order to make a submission on this application.

In accordance with Section 291(4) of the Planning and Development Act 2000, as amended, you are requested to submit to the Commission a report setting out the views of the authority on the effects of the proposed development on the environment and the proper planning and sustainable development of the area of the authority within a period of 10 weeks from the making of the application to the Commission. The application was made to the Commission on the 22nd April 2026 and I can confirm that the deadline for the submission of the report is, therefore, the **30th June 2026**.

The Commission may in addition to the report referred to above require the coastal planning authority to submit the information as set out in section 291(5-7).

A copy of the planning authority report should also be placed on the public file at the planning authority office.
