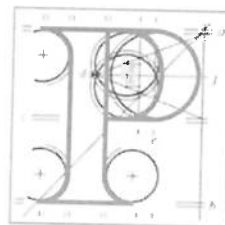

Dear Sir/Madam.

We are acting on behalf of Ann Chambers.

With reference to the material assets/agriculture we consider that this is substantially wrong. The report makes reference to a beef enterprise only; but in fact there is a beef, sheep and horses enterprise of significance. In view of the closeness of the road to a sand arena, we consider that the impact is profound not major, and we consider that the arena will not be usable during construction as presently designed and possibly not suitably post construction.

We consider that a substantial noise barrier is required between the arena and the road during and post construction. As presently designed, there is a serious health and safety issue here arising from the new road.

Pending confirmation, we consider there could be a health and safety issue on the bridge on the L7094 for our client and the members of Donegal Harriers and their guests.
