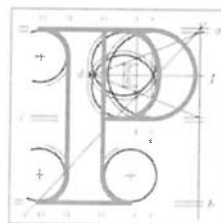

We are acting on behalf of Ms Charmaine Hughes.

There is no material assets report in relation to the lands at plot 2097.

The land take is excessive. The land take required for the construction of the road is approximately 10% of the land. The original land take proposed was 4 acres with two accesses being provided to the remainder of the lands.

The landowners are willing to allow the fill from 2097 be used to build up the roundabout location, provided that the land is reinstated and return to them as surplus lands after.
