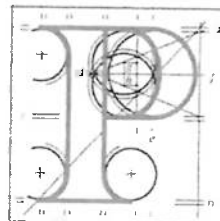

We are acting on behalf of James Rodgers.

The land take here is excessive, in particular south of plot 3022. While there is a material assets report summary on table 15.32 section 3 plot 3021, no representative of Donegal county council our client or most other clients have been interviewed in respect to their farming activity.

We consider the assessment does not reflect correctly on the impact on this farm, the land is severed with a difficult access. We reject entirely the effect described in the report as moderate as we consider it to be severe/major.
