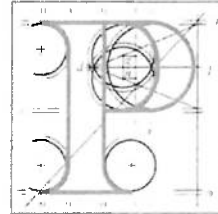

An Coimisiún Pleanála has received your recent submission and oral hearing request in relation to the above-mentioned proposed road development and will take it into consideration in its determination of the matter.

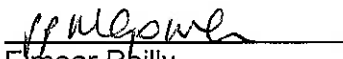
