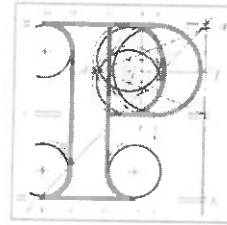

The land take here is excessive at plot 1005A.101 and we are objecting to the portion of the land take at the west side of the holding which is marked by a yellow triangle on the land ownership mark to facilitate an active travel path because it is not necessary infrastructure
