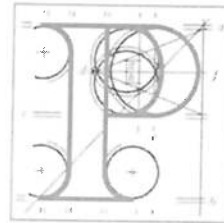

The land take is excessive, this land is being acquired for the purposes of a roundabout and therefore we consider the land take is grossly excessive.

There appears to be a contradiction on the design between the landscape mitigation drawing at this location and the design drawing at this location for example existing utilities, this clearly shows that the land take is excessive

None of this land is an SAC, NHA, SPA and PNHA

We are requesting that ACP reduce size of the permanent land take to sufficiently accommodate the roundabout and associated drainage, and that the balance of the land would be temporary land take.
