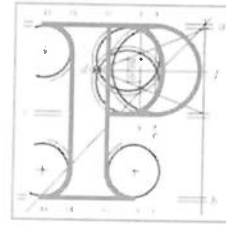

Objection Joseph Gallinagh Snr. & Seamus Gallinagh – Plot No's: 1052 & 1162

Dear Sir/Madam.

We are acting on behalf of Joseph Gallinagh Snr. & Seamus Gallinagh.

Location of the attenuation pond is not in the appropriate location on the Glenfin road.

In view of the fact that this is very good agricultural land and in view of the fact there is located at plot 1010 approx 75 meters east of plot 1052 which is presently wilderness which would be ideally suitable as an alternative location for the attenuation pond.

We are requesting that the commission direct Donegal County Council to reconsider moving the attenuation pond from plot No. 1052 to 1010, and we are aware that the owner of 1010 has no objection to this occurring.

Part of the lands of 1052 and 1162 are subject to partial flash flooding during heavy rainfall and this area acts as a natural attenuation for such flood water, due to these two plots being used for natural attenuation, would it force the water to go someplace else. We consider the design for the drainage inadequate and we have serious concerns that our clients house could be subject to flooding.
