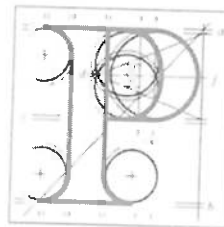

We are acting on behalf of Kevin and Teresa O'Malley.

Our client's in principal are not objecting to the scheme. There is an obligation on the acquiring authority to properly establish the facts. With reference to appendix C16.01-landtake assessments has described the impact as low to medium and also as moderate. These two descriptions are a contradiction, both of which we disagree with. We consider the impact to be significant both during construction and post construction as the works will remove mature trees at the end of their garden and their enjoyment of their external amenity due to the impact of the new road.
