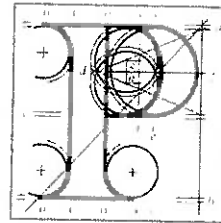

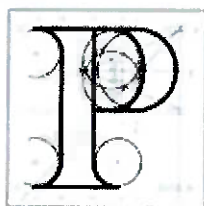

Letterkenny Chamber is the only full time Chamber of Commerce in Donegal affiliated to Chambers Ireland. We work for the interests of the business community in Donegal while also promoting economic development in the region with a range of partners and key stakeholders.

We have 340 members representing 15,000 employees from all sectors and sizes of business including FDI and many indigenous SMEs all of which share growth ambitions.

Letterkenny is the largest urban centre in Donegal with a population of 22000 and is now larger than Sligo. As the commercial capital with a University, Regional Hospital and some large employers it grows in size by around 20,000 each day putting pressure on all aspects of its infrastructure. The town is a significant growth centre as identified in the NDP and the North West City Region is being recognised as a strong cross border conglomeration (4th largest city on the island), however for many decades the town and region has lacked the infrastructure that could deliver the connectivity we need.

Over many years infrastructure has ranked highly among members concerns. Our businesses across the region and key stakeholders have clearly shown ambition and although the dial is moving the County Donegal statistics show a County that is still struggling across the metrics with infrastructure still being one of major concern.

Connectivity is key to achieving a thriving economy enabling the region to contribute positively to a successful Ireland.

The result of the current routes is congestion at peak times, increased road fatalities and a negative impression and reputation for the towns of Letterkenny and Ballybofey/Stranorlar. The peak time impression of congestion is off-putting to investors, visitors and potential employees.

County Donegal has no rail infrastructure and little prospect of its development. Most other counties in Ireland have alternative travel options while the NW is left with no option other than continued reliance on the car making it the worst performing County in the Northern & Western Region for infrastructure.

This Infrastructure deficit acts as an inhibitor to enterprise growth and international investment. It is not just about access but about productivity and livelihoods. In order to be a connected region and become a net contributor to the Irish economy the region needs infrastructure that is to a comparable standard to the rest of the country.

5. Grounds

The Donegal TEN-T route improvement project is welcomed by members and key stakeholders across County Donegal.

This proposed new route would deliver:

- A new route into Letterkenny allowing town centre traffic to flow more easily and reduce congestion.
- It would significantly improve the road from Manorcunningham to the border at Lifford and onwards to Dublin so enabling safer and quicker access to customers, clients and investors.
- A bypass for Stranorlar/Ballybofey would also result in much more predictable travel times to the south of the County and at the same time reduce the stress and congestion on the towns.

In this modern economy we believe it is not acceptable to still be moving goods, and people on single carriageway roads that are unsafe and not suitable for purpose.

Our members have waited for a long time to see these routes developed and we support this application.
