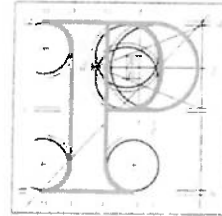

We wish to submit an observation in relation to the T Ten road development Section 2 N56/N13 Letterkenny to Manorcunningham. The proposed road is approximately 70 meters from the properties at L-5784 on the attached map, currently agricultural land with no/low noise impact.

The large cut area planned for one side of the road will have a detrimental effect to the properties in this area due to the increased potential for significant noise deflection causing increased noise pollution. There are no noise mitigation structures planned to mitigate this noise deflection for the residents in this area. These concerns have been raised previously with the project team.

Noise barriers are planned at S2 NB001 and we would ask that the decision not to place noise mitigation measures is reviewed as part of the planning process for the properties affected in this area.
