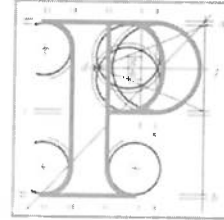

Dear Sir/Madam.

We are acting on behalf of Michael Gallagher.

While our client accepts the need from the road, we consider the assessment Chapter 15 Material Assets is incorrect in view of the impact on his farm due to the new road.

There is a well located approx. 100 meters from the road which will be substantially eliminated, this is a 4-foot dug well, there is a high risk the new road will impact the well, the well will need to be monitored during construction.

There is a 3-foot well located to the entrance of his property which may be impacted.

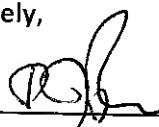
There are springs in the field opposite Connor O'Dowd's land; the spring well in the farmyard is providing water to Connor O'Dowd's house. These spring wells are pipe to water tanks with gravity flow.

There is a water course between property 1107 (John Jackson) and 1108 (our client) which is a never-ending supply of water and our client has a gravity flow onto his lands from this – this will be cut off.

In view of the impact of water supply to his farm we consider the assessment is in correct.
