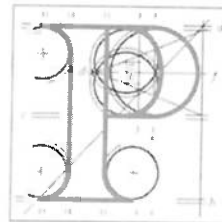

Dear Sir/Madam.

We are acting on behalf of Seamus Crumlish.

The land take is excessive. There is natural valley within the plot and the adjoining plot which I consider is the natural location for the attenuation pond. The land take is removing 29% of the plot having a significant effect on the holding. The material assets report is incorrect stating that 29% of the plot is removed when in fact it is 1.66 Ha out of 3.70 Ha being 44% of the parcel. The effect on the plot is profound.
