APPLICATION TO AN COIMISIÚN PLEANÁLA PURSUANT TO SECTION 32 OF THE GAS ACT, 1976 (AS AMENDED) FOR AN ACQUISITION ORDER GAS TO BORD NA MÓNA, EDENDERRY.

Dear Sir / Madam,

Pursuant to Section 32 of the Gas Act, 1976, (as amended), Gas Networks Ireland (GNI) hereby applies to An Coimisiún Pleanála, for an Acquisition Order to acquire compulsorily the rights over land and the land, details of which are specified in the Schedule hereto for the construction, operation and maintenance of a gas pipeline (to be known as Gas to Bord na Móna, Edenderry) and such other works, services, facilities and other things as are necessary therefor. The proposed pipeline will commence at the above ground installation in the Townland of Kilwarden in the County of Offaly and will terminate at the proposed above ground installation in the Townland of Kilcumber, in the County of Offaly.

Pursuant to Section 31 of the Gas Act, 1976 (as amended), GNI also applies to An Coimisiún Pleanála for confirmation of the deviation limits within which GNI considers it may be necessary to construct the said pipeline or to do anything reasonably necessary for or ancillary or incidental to such construction, which deviation limits are shown coloured green on the drawings enclosed with this application.

The directions of An Coimisiún Pleanála under Articles 2 and 3 of the Second Schedule to the Gas Act, 1976 (as amended) are hereby requested.

The proposed pipeline is a strategic gas infrastructure development for the purposes of the Planning and Development (Strategic Infrastructure) Act, 2006.

We understand there are no fees relating to this application as confirmed by you in email dated 28th April 2026.
