Dear Bridget,

I sincerely appreciate our conversation earlier today. I wanted to reiterate our points and further discuss our plans for the site in Carlow.

As we touched upon, my team and I have been diligently working with architects to explore potential developments for the site. However, given the current economic climate in Ireland, we've encountered challenges in finding a commercially viable solution. With commercial vacancies at their highest levels, securing funding for such a venture has proven difficult.

After a recent on-site meeting with housing bodies, builders, and stakeholders, we've identified housing as a more feasible option. We've even identified certain buildings that could be repurposed for this purpose under the iPass scheme. Before moving forward, I believe it's crucial to engage in discussions with the council to explore any mutually beneficial opportunities for site development.

Additionally, I'd like to address the matter concerning the properties on Charlotte Street. I recall our prior discussion regarding the letter I received regarding their potential listing on the dereliction site list. Nicola had mentioned that the council would hold off on this listing if they observed active efforts toward site development. While I remain committed to this endeavor, I wanted to bring to your attention the challenges we're facing amid these economic difficulties.

I would greatly appreciate any clarification or guidance you could provide on these matters.

Thank you for your attention to these issues, and I look forward to further discussions.
