RECORD OF CHIEF EXECUTIVE'S ORDER

PA148 Acquisition of Open Space Lands at Talbot Downs and Talbot Court, Castleknock under Section 45 of the Planning and Development Act 2000 (as amended)


Planning permission was granted under the Planning Acts to Lido Construction Ltd. for a residential development at site bounded by Navan Road, Scotts Restaurant/Bar Navan Road Dual Carriageway. The planning permission contained a condition requiring the provision of land as open space or it was either explicit or implicit in the application for the permission that land would be provided as such open space. Chief Executive Order PK/111/97 authorised the acquisition of open space lands at Talbot Downs and Talbot Court Castleknock on the foot of a Deed of Dedication submitted by Lido Construction Ltd.

Fingal County Council, as planning authority, has previously served a written request for the open space lands at Talbot Downs and Talbot Court Castleknock to be provided to the Council, however the open space lands have yet to be transferred to the Council.

It is now recommend that the procedure pursuant to Section 45 of the Planning and Development Act, 2000 be initiated to vest the open space lands at Talbot Downs and Talbot Court Castleknock in the ownership of the Council, that an acquisition notice be published in a newspaper circulating in the district of Fingal, that a copy of the acquisition notice be served on the owner(s) of the lands described and that an application be made to An Coimisiún Pleanála to confirm the acquisition notice in order to vest the lands, as shown delineated in red on Drawing Index No. 5506, in the ownership of the Council.

I concur with the above and recommend payment of the Council's costs in this matter together with any additional approved costs that may arise and that in accordance with the provisions of this Order and subject to confirmation of the acquisition notice, the Council is hereby authorised to commence the statutory procedures to vest said lands in the ownership of the Council for the aforesaid purpose.

Provision for this expenditure has been made in Job Code 63192025.


