Dear Sir / Madam,

The applicant should be required to engage directly with the air navigation service provider AirNav Ireland to confirm that the proposed wind farm development and any associated cranes will not impact on en-route communications, navigation and surveillance equipment (CNS). Evidence of engagement and consultation with the above entity should be provided to the Planning authority by the applicant / developer.

In the event of planning consent being granted, the applicant should be conditioned to contacting the Irish Aviation Authority to;

- (1) agree an aeronautical obstacle warning lighting scheme for the wind farm development,
- (2) provide as-constructed coordinates in WGS-84 format together with ground and blade tip height elevations at each wind turbine location and;
- (3) notify the Authority of the intention to commence crane operations with at least 30 days prior notification of their erection in accordance with S.I. 215 of 2005 Irish Aviation Authority (Obstacles to Aircraft In Flight) Order.
