LIMERICK CITY AND COUNTY COUNCIL (CASTLECONNELL FLOOD RELIEF SCHEME) COMPULSORY PURCHASE ORDER 2026

LOCAL GOVERNMENT ACT 2001 (AS AMENDED)

IN THE MATTER OF COMPULSORY PURCHASE ORDER UNDER SECTION 76 OF AND THE THIRD SCHEDULE TO THE HOUSING ACT, 1966, AS AMENDED BY SECTION 198 OF THE RESIDENTIAL TENANCIES ACT, 2004, AS EXTENDED BY SECTION 10 OF THE LOCAL GOVERNMENT (NO. 2) ACT, 1960 (SUBSTITUTED BY SECTION 86 OF THE HOUSING ACT, 1966) AND AMENDED AND EXTENDED BY THE PLANNING AND DEVELOPMENT ACT 2000 (AS AMENDED) (INCLUDING PART XIV, SECTION 212, SECTION 213 AND SECTION 222 THEREOF); THE ROADS ACTS 1993 AS AMENDED (INCLUDING SECTION 6 AND THE SECOND SCHEDULE TO THE ROADS ACTS 1993 AS AMENDED; THE LOCAL GOVERNMENT ACTS 1925 TO 2019 INCLUDING SECTIONS 11 AND 184 OF THE LOCAL GOVERNMENT ACT, 2001 AS AMENDED; THE LOCAL GOVERNMENT (NO.2) ACT, 1960; THE PLANNING AND DEVELOPMENT ACT 2000 AS AMENDED AND ALL OTHER ACTS THEREBY ENABLING

Limerick City and County Council (hereinafter referred to as “the Local Authority”) in exercise of the powers conferred upon them by Section 76 of the Housing Act, 1966, and the Third Schedule thereto, as extended by Section 10 of the Local Government (No. 2) Act, 1960 as substituted by Section 86 of the Housing Act, 1966 as amended by Section 6 and the Second Schedule to the Roads Act, 1993 (as amended) and as amended by the Planning and Development Act, 2000 (As Amended) (including Part XIV, sections 213, 213(2), 222 thereof) and pursuant to the provisions of the Local Government Act 2001 (as amended), and all other enabling legislation, has made an order entitled as above which is about to be submitted to An Coimisiún Pleanála for confirmation.

The Castleconnell Flood Relief Scheme, to which the Compulsory Purchase Order relates, was approved by An Coimisiún Pleanála on 3rd November 2025 (ABP-321350-24).

NOW THEREFORE it is hereby ordered that:

1. Subject to the provisions of this order, the Local Authority are hereby authorised:

- a. to acquire compulsorily permanent acquisition, for the purposes of the construction and maintenance of the Castleconnell Flood Relief Scheme through the townlands of Coolbane, Cloon and Commons and Lacka giving effect to the objectives contained in the Limerick Development Plan 2022-2028 and the Castleconnell Local Area Plan 2023-2029, the land described in Part I of the Schedule hereto, which land is shown coloured grey and outlined in red on Maps marked with the reference “**Limerick City and County Council (Castleconnell Flood Relief Scheme) Compulsory Purchase Order 2026**” and sealed with the seal of the Local Authority and deposited at the offices of the Local Authority (hereinafter referred to as ‘the Deposited Maps’),

and,

- b. to acquire compulsorily permanent wayleave for the purposes of the construction of the Castleconnell Flood Relief Scheme through the townlands of Coolbane, Cloon and Commons and Lacka giving effect to the objectives contained in the Limerick Development Plan 2022-2028 and the Castleconnell Local Area Plan 2023-2029, the land described in Part II of the Schedule hereto which land is shown coloured yellow and outlined in red on the Deposited Maps.

The permanent wayleaves shall convey the right for the Local Authority, its successors in title, assigns, tenants, servants or agents, contractors or licensees to (a) pass and (b) repass at all times;

- (i) To construct, lay, keep, operate, maintain, repair and inspect flood defence works on or under the land specified in Sub-Part B below, together with the right, (c) to enter with all necessary vehicles, plant, and machinery upon the said land always for any of the said purposes,

And,

- c. to acquire compulsorily the rights of ways for the purposes of the construction and maintenance of the Castleconnell Flood Relief Scheme through the townlands of Coolbane, Cloon and Commons and Lacka giving effect to the objectives contained in the Limerick Development Plan 2022-2028 and the Castleconnell Local Area Plan 2023-2029, the land described in Part III of the Schedule hereto which land is shown coloured blue and outlined in red on the Deposited Maps,

The rights of way shall convey the right for the Local Authority, its successors in title, assigns, tenants, servants or agents, contractors or licensees to (a) pass and (b) repass at all times;

- (i) To enter with all necessary vehicles, plant and machinery upon the said plot of land, for the purposes and by all means in connections with the use and occupation of the Local Authority, their servants or agents, workmen or contractors for the purposes of the Castleconnell Flood Relief Scheme
- (ii) Such rights include the right to do anything reasonably necessary for or ancillary or incidental to the Works related to and incorporating the Castleconnell Flood Relief Scheme to be carried out, erected or constructed upon the said lands described in Part I, II, IV or V of this Schedule.

And,

- d. To acquire compulsorily temporary acquisition for the purposes of the construction of the Castleconnell Flood Relief Scheme through the townlands of Coolbane, Cloon and Commons and Lacka giving effect to the objectives contained in the Limerick Development Plan 2022-2028 and the Castleconnell Local Area Plan 2023-2029, the land described in Part IV of the Schedule hereto which land is shown in green hatch and outlined in red on the Deposited Maps,

And

- e. To compulsorily extinguish the private and public right of way for the purposes of the construction of the Castleconnell Flood Relief Scheme through the townlands of Coolbane, Cloon and Commons and Lacka giving effect to the objectives contained in the Limerick Development Plan 2022-2028 and the Castleconnell Local Area Plan 2023-2029, described in Part V of the Schedule hereto which is shown coloured blue and magenta respectively marked on the Deposited Maps.

2.

- a. The land described in Part I of the Schedule hereto shown coloured grey and outlined in red and referred to on the Deposited Maps is land other than land consisting of a house or houses unfit for human habitation and not capable of being rendered fit for human habitation at reasonable expense. The land included in the Schedule is situated in the functional area of Limerick City and County Council.
- b. The land described in Part II of the Schedule hereto shown coloured yellow and outlined in red and referred to on the Deposited Maps is land other than land consisting of a house or houses unfit for human habitation and not capable of being rendered fit for human habitation at reasonable expense. The land included in the Schedule is situated in the functional area of Limerick City and County Council.

- c. The land described in Part III of the Schedule hereto shown coloured blue and outlined in red and referred to on the Deposited Maps is land other than land consisting of a house or houses unfit for human habitation and not capable of being rendered fit for human habitation at reasonable expense. The land included in the Schedule is situated in the functional area of Limerick City and County Council.
- d. The land described in Part IV of the Schedule hereto shown coloured green hatch and outlined in red and referred to on the Deposited Maps is land other than land consisting of a house or houses unfit for human habitation and not capable of being rendered fit for human habitation at reasonable expense. The land included in the Schedule is situated in the functional area of Limerick City and County Council.
- e. The land described in Part V of the Schedule hereto shown coloured blue and magenta and outlined in red and referred to on the Deposited Maps is land other than land consisting of a house or houses unfit for human habitation and not capable of being rendered fit for human habitation at reasonable expense. The land included in the Schedule is situated in the functional area of Limerick City and County Council.

3. Subject to any necessary adaptation, the provisions of:

- a. The Land Clauses Acts, (except Sections 127 to 132 of the Land Clauses Consolidation Act, 1845, and Article 20 of the Second Schedule to the Housing of the Working Classes Act, 1890), and
- b. The Acquisition of Land (Assessment of Compensation) Act, 1919, as amended by the Acquisition of Land (Reference Committee) Act, 1925, the Property Values (Arbitrations and Appeals) Act, 1960, and the Local Government (Planning and Development) Act, 1963 (as applied by Section 265(3) of the Planning and Development Act, 2000) and the Planning and Development Acts, 2000-2022.

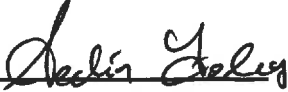
As modified by the Third Schedule to the Housing Act, 1966 (as amended) are hereby incorporated in this Order and the provisions of those Acts shall apply accordingly.
